Minutes of virtual GBM of ROS t held on 18.10.2020 at 4.30 pm

1. Meeting called to order by president Dr R K Sharma.
2. Roll call was done & recorded. Meeting was adjourned for 15 minutes due to lack of quorum & recalled after 15 minutes.
3. 2-minute silence for deceased members Dr J P Tak, Dr D S Bawalia & Dr Pawan Sharma
4. Welcome address by president Dr R K Sharma
He praised the work of whole executive specially of Dr Sandeep Vijay for working hard in this difficult time of pandemic. He said that ROS could not organise any major event due to covid 19 pandemic. He praised hard work of Dr Sandeep Vijay, Secretary, ROS during covid 19 for his untiring work for benefit of ROS members & community
5. Confirmation of minutes of last GBM held in Jaipur on 21 September 2019
Dr Sandeep Vijay read minutes of last GBM. This was approved by GBM proposed by-Dr Ashok Bairwa, seconded by Dr R K Verma.
6. Secretary's report: -
