B. Secretary Dr Sandeep Vijay informed committee of Income tax notice of RS 39,00,000.00 received from IT department for amount received after AIOC 2017. An appeal was filed against this order & 20 % of demand notice was deposited in IT deptt. The case is still pending

C. GBM requested Dr K K Kanjolia to explore possibility of land allotment at concessional rates at Jaipur to construct ROS office / a property with rental value should be purchased to evade tax before due date of amnesty.

D. Settlement of dues of ROSCON 2018, Ajmer - Outgoing treasurer Dr Mayank Agarwal informed house that after repetitive request to LOC, ROSCON 2018 (organised by Ajmer ophthalmological society) they have not furnished expenditure details of Rs 4, 40, 000.00. ROS has to give around 5,00,000.00 as profit sharing to Ajmer ophthalmological society. CA of ROS has advised to set off this amount & make a letter of understanding from both parties of NO DUES. Otherwise, ROS will have to pay tax on this amount. Executive committee agreed to get letter of understanding from both parties & GBM approved it. However, GBM **TOOK A STRONG NOTE OF IT & ASKED SECRETARY TO WRITE STRONG WORDED LETTER TO AJMER OPHTHALMOLOGICAL SOCIETY FOR THIS ACT. GBM ADVISED TO TAKE STRICT DECISION INCLUDING DEBARRING OF AJMER OPHTHALMIC SOCIETY FOR NEXT CONFERENCE IF THEY DO NOT GIVE LETTER OF UNDERSTANDING.**

E. Since ROI on FDRs is going down GBM authorized secretary & treasurer to explore possibility to invest in safe government bonds/ corporate bonds & similar way. Help of financial advisor can be taken.
