Subject: - Requirement of number of beds in **exclusive eye hospitals** for empanelment in Chiranjeevi yojana (ABMGRSBY)

Sir,

Rajasthan Ophthalmological Society is the only organization representing all eye specialist (both govt & private sector) of Rajasthan.

We want to draw your kind attention to order no F.1008 (169)/RSHAA /ABMGRSBY/ empanelment/2021/1711 dated 20.06.2022 issued by your office.

In this order it is made mandatory to have 30 beds for empanelment under this scheme. Previously **eye hospitals** were given relaxation as exclusive eye hospitals are mostly day care centres & they hardly require such a huge bed strength. This order has deprived all well established & popular eye hospitals to serve people of Rajasthan under this scheme.

**In any other government scheme (CGHS/RGHS etc) only 5 beds criteria are made mandatory.**

We request you to reconsider this decision & keep minimum bed strength to 5 only so that maximum eye hospitals can get empanelment under this scheme & can serve needy population of this state & fulfil dream of health for all of state government.
