10. Many members of the ROS submitted points for consideration at the GBM regarding online voting and the election process for the vice president. These topics were discussed during the meeting, and a majority agreed on the following points: The voting process will be conducted in a hybrid format, allowing for both online and offline participation. This format will apply to all positions, including the vice president, but will exclude the zonal representative position. The zonal representative will be appointed by the respective zonal society to ensure effective local governance.

11. During the General Body Meeting (GBM), a significant discussion took place regarding the voting rights of postgraduate residents. Several members expressed concerns about whether these residents should be granted voting rights. After thoroughly examining the issue and engaging in ample dialogue, a majority of members reached a consensus. It was agreed that postgraduate residents would be granted associate membership throughout their residency. This status allows them to enjoy all the benefits of membership, with the notable exception of voting rights, which will remain unavailable until they obtain their Registration Medical Council (RMC) certification for their postgraduate training.

12. Dr. Sandeep Vijay has put forth a proposal to establish an Election Reform Committee aimed at enhancing the integrity and efficiency of the electoral process. This initiative is intended to address existing challenges and implement changes that will reinforce members' trust in elections..
