Minutes of GBM October 2025 Pushkar, Ajmer

ROS General Body Meeting Summary

1. The General Body Meeting of Rajasthan Ophthalmological Society (ROS) was held on Saturday, 4th October 2025 at 5:30 PM in Hall A, Jollywood Resorts.
2. The meeting began with homage.
3. Confirmation of last year's minutes was proposed by Dr. Nepalia and seconded by Dr. Rajkumar Sharma ji.
4. Secretary's report was cleared, proposed by Dr. Anil Kothari and seconded by Dr. Ahluwalia.
5. CSC report was proposed by Dr. V.K. Sharma and seconded by Dr. Suresh Pandey.
6. Treasurer's report was proposed by Dr. Arun Kshetrapal and seconded by Dr. Suresh Pandey.
7. Editor Journal report was proposed by Dr. Harsholiya ji and seconded by Dr. Rahul Sharda.
8. The major discussion took place on the approval of recommendations of the Election Reforms Committee and Constitution Amendment Committee.
9. Resident voting remained the main point of deliberation and took considerable time.
10. More than 100 members attended the GBM.
11. It was proposed that online voting should be implemented for all posts in a graded manner.
12. It was also suggested that voting for the Vice President post may continue through open voting.
13. For the resident voting matter, a five-member committee was proposed consisting of Dr. Pankaj Sharma, Dr. Murli, and three past presidents, preferably from educational institutes.
14. The committee will examine the matter further and submit recommendations.
15. It was discussed that ways should be explored to reduce faculty travel and accommodation expenses during conferences.
16. A proposal was made to increase online presentations by outside faculty, both from within India and abroad, so that academic sessions can benefit from wider expert participation while reducing logistical burden.
17. Regarding the Rajasthan Premier League, it was suggested that more opportunities should be given to new members so they can present themselves and participate actively in academic activities.
